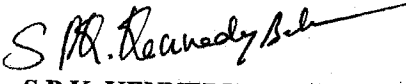

2.1 About Mahatma Gandhi Postgraduate Institute of Dental Sciences

Pondicherry Dental College was established in the year 1990 in a building with only 2 rooms. It was subsequently renamed as Mahatma Gandhi Dental College & Hospital in the year 1995. Mahatma Gandhi Dental College and Hospital was upgraded to present status as Mahatma Gandhi Post Graduate Institute of Dental Sciences on 08.09.2005 vide G.O.Ms.No.57 of the Govt. of Pondicherry. It is the only Dental Institute in the country in the Govt. sector on par with other leading Medical Institutes in the country. Mahatma Gandhi Postgraduate Institute of Dental Sciences is offering 5 year BDS course (inclusive of one year paid Compulsory Rotatory internship) and 3 year MDS courses in seven specialities.

The Institution has chosen the Motto “knowledge is power” emphasizing that knowledge is the most essential thing to empower a person. Since the inception, 17 batches of students have graduated from this Institution and 10 batches have completed post-graduation (M.D.S). The degrees (BDS and MDS) are recognized by the Dental Council of India, and Ministry of Health Family Welfare, Government of India and this Institute is permanently affiliated to the Pondicherry University (A Central University).

4. General Instructions to Applicants or agency

This Request for Proposal (RFP) represents a significant opportunity to enter into a strategic partnership with Mahatma Gandhi Postgraduate Institute of Dental Sciences. The RFP will assist in identifying and selecting the preferred agency

The Mahatma Gandhi Postgraduate Institute of Dental Sciences will review and evaluate the submitted proposals. Vendors whose proposals meet the evaluation criteria will be invited to demonstrate their proposed system solutions.

The evaluation process for Proposal will be conducted in stages as defined in Section B of this Request for Proposal (RFP).

- A. Applicants or Agencies are required to submit their proposal via <https://pudutenders.gov.in>, as specified in the RFP e-tender notice (third call).**
- B.** Pre-bid meeting may take place (virtually as well), if necessary.
 - i. Purpose of the pre-bid meeting will be to clarify issues and queries regarding this RFP document.
 - ii. All clarifications and interpretations issued by Mahatma Gandhi Postgraduate Institute of Dental Sciences in writing shall be deemed to be part of the bidding documents.
 - iii. Verbal clarification(s) and information given by Mahatma Gandhi Postgraduate Institute of Dental Sciences, or its employees or representatives

- shall not in any way or manner be binding on Mahatma Gandhi Postgraduate Institute of Dental Sciences and shall not alter the terms of the RFP.

No contractual obligation what Agency’s shall arise from this Proposal process.

Binding Clause

All decisions made by Mahatma Gandhi Postgraduate Institute of Dental Sciences regarding this Proposal shall be final and binding on all Applicants or Agency.

Vendor’s Obligations

The applicants or Agencies will be responsible for managing the activities of its personnel and will be solely responsible for any violation.

The final selection would be based on Composite Score as described in this section and the Civil project pricing submitted by the Agencies after the Onsite Demonstration.
